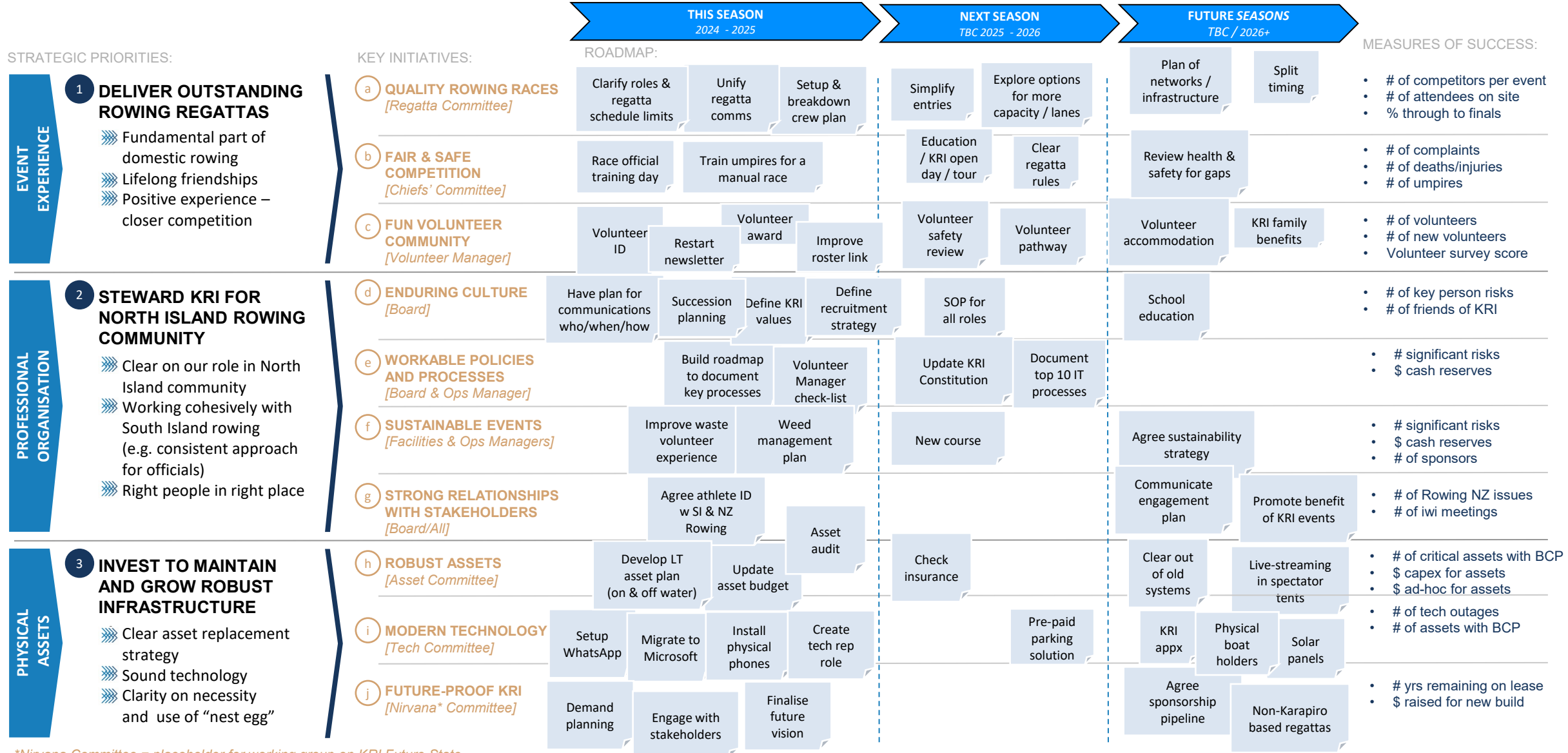

- Right people in right place

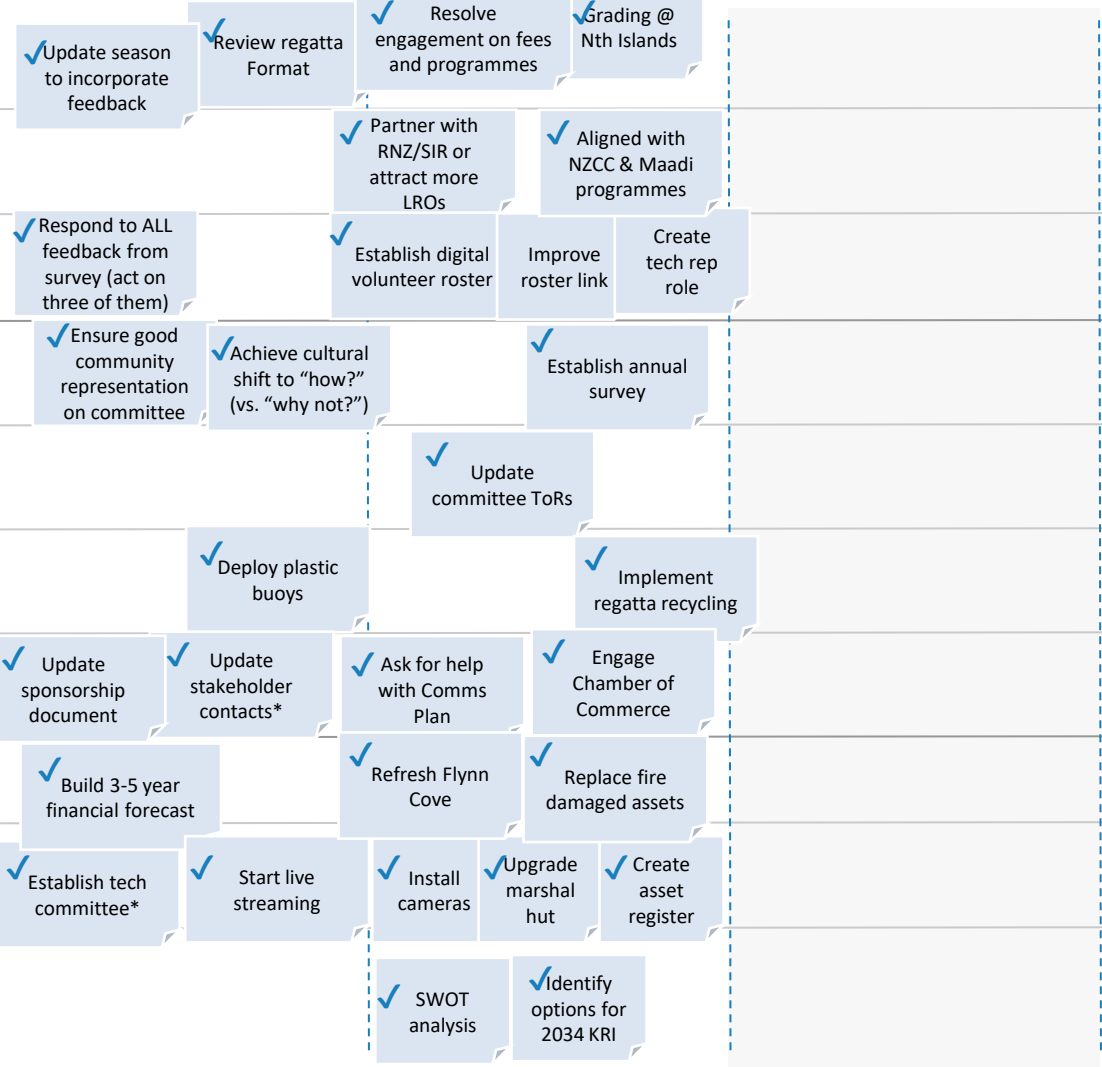
3 INVEST TO MAINTAIN AND GROW ROBUST INFRASTRUCTURE

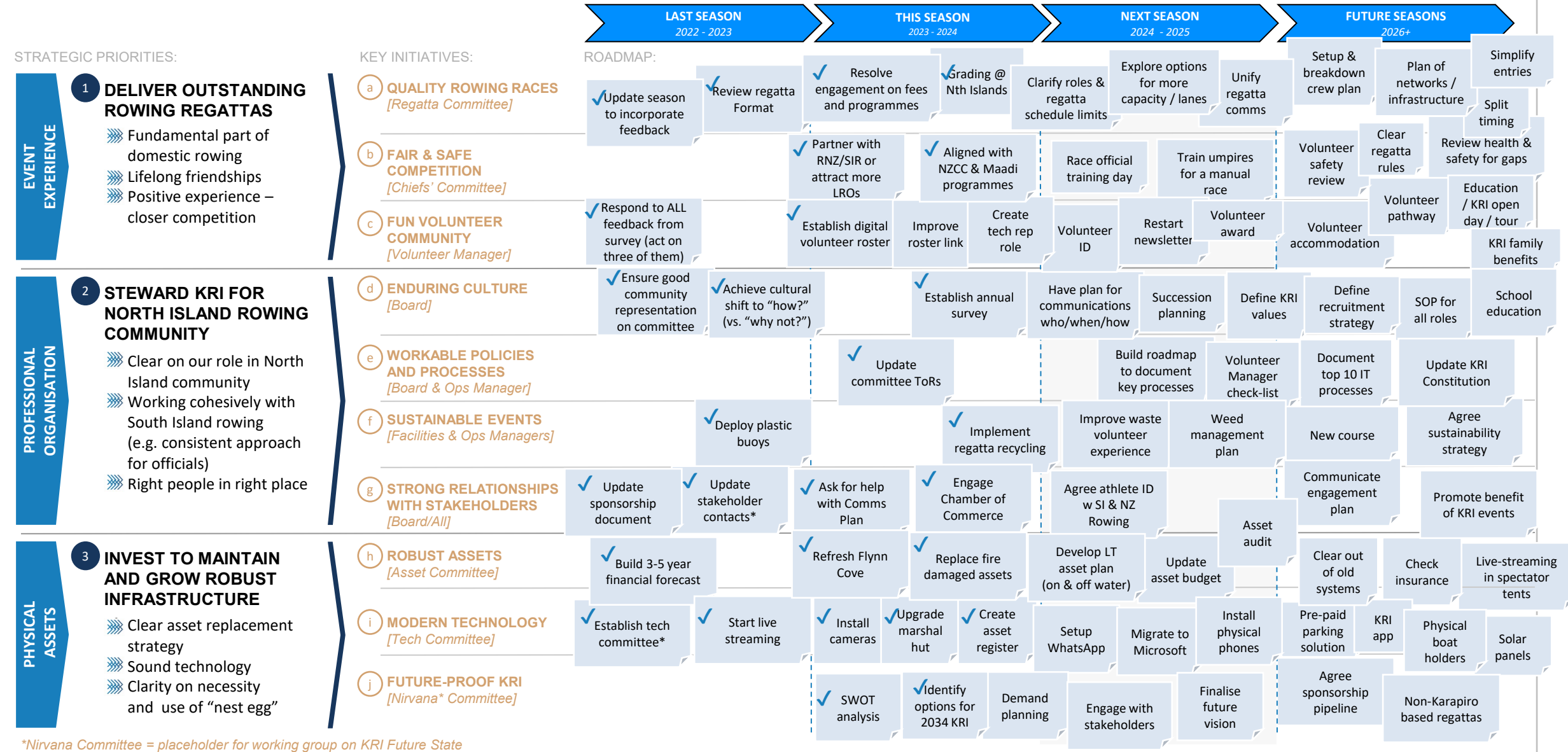
